## Ministry of Justice's Announcement No. 2015–251

The Ministry of Justice hereby announces revised criteria (age, education, annual income, etc.) for persons who fall under Item (I) of 27. Resident (F-2) status of Table 1 of the Enforcement Decree of the Immigration Control Act. (Revised criteria of the Ministry of Justice's Announcement No. 2013-151 on April 17, 2013)

## Minister of Justice

Announcement on revised criteria (age, education, annual income, etc.) for persons who fall under Item (I) of 27. Resident (F-2) status of Table 1 of the Enforcement Decree of the Immigration Control Act

## 1. Applied Individuals

- The revised criteria will apply to persons with a professional occupation\* who have legally stayed in the Republic of Korea for at least one year on one of the following statuses referred to in Table 1 of the Enforcement Decree of the Immigration Control Act and who do not have any grounds for disqualification\*\*:

Professor (E-1), Foreign Language Instructor (E-2), Researcher (E-3), Technical Instructor/Technician (E-4), Professional (E-5), Artist/Athlete (E-6), Foreign National of Special Ability (E-7), Student (D-2), Long-term News Coverage (D-5), Religious Worker (D-6), Intra-company Transferee (D-7), Corporate/Foreign Investor (D-8), International Trade (D-9), and Job Seeker (D-10)

- \* As for Artists/Athlete (E-6) holders, the revision does not apply to entertainers at hotels or adult entertainment establishments for tourists (E-6-2); As for Student (D-2) or Job Seeker (D-10) holders, the revision applies to the persons who have earned (or are expected to earn) a master's degree or higher from a Korean university and whose employment in a Korean company, etc. is confirmed. (Employment is confirmed when the person is eligible for one of the statuses from Professor [E-1] through Foreign National of Special Ability [E-7] and has singed an employment contract with a relevant institution, organization, company, etc. [Except for E-6-2 status])
- \*\* (1) You have been sentenced to imprisonment or heavier punishments (except when the punishment became ineffective according to the Act on the Lapse of Criminal Sentences). (2) You have been sentenced to fines or lighter punishments due to violation of domestic laws including the Immigration Control Act three times or more within two years from the date of application, or you have failed to pay the fines. (3) You have grounds for entry prohibition or you are considered to compromise national

security, social order, public welfare and other national interests of the Republic of Korea. (4) You have submitted forged documents when applying for the change of sojourn status.
